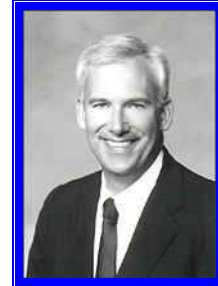

At the winter board meeting of the NCFRW, we adopted these resolutions as being the major legislative initiatives for 2008.

RESOLUTION -- JESSICA LUNSFORD ACT

By the North Carolina Federation of Republican Women

WHEREAS, North Carolina is one of only a few remaining states that has not enacted some form of Jessica's Law; and

WHEREAS, child predators have increasingly been a blight on our society and have caused severe damage to our children and our culture; and

WHEREAS, our first responsibility is to protect our children from those who would commit harm against them and to severely punish those who perpetrate acts of abuse against them; and

WHEREAS, NCFRW has promoted legislation that is in the process of becoming law.

BE IT RESOLVED, NCFRW strongly urges all legislators to promptly pursue final passage and enactment of this much needed legislation House Bill 933 known as The Jessica Lunsford Act.

RESOLUTION -- UNBORN VICTIMS ACT

By the North Carolina Federation of Republican Women

WHEREAS, North Carolina does not have a law to provide for charging those who commit murder or manslaughter of a pregnant woman with additional charges for the death of her infant; and

WHEREAS, North Carolina does not have a law to provide for separate charges against those who commit a felony or misdemeanor in an act of violence that causes injury to a pregnant woman resulting in the loss of life to her unborn child; and

WHEREAS, North Carolina is one of only a few states not offering such laws for the protection of an unborn victim; and

WHEREAS, NCFRW has always been a strong advocate for women and children.

BE IT RESOLVED, that NCFRW hereby strongly urges all members of the North Carolina Legislature to take immediate and decisive action to remedy this glaring miscarriage of justice and to enact legislation such as House Bill 263 that punishes those who do harm to an unborn child.

RESOLUTION—PROTECTION OF MARRIAGE ACT

By the North Carolina Federation of Republican Women

WHEREAS, an overwhelming majority of North Carolinians support marriage as a sacred union between one man and one woman; and

WHEREAS, many judges across the nation have overturned legislative decisions declaring marriage to be such a union; and

WHEREAS, North Carolina Federation of Republican Women recognizes the importance of preserving marriage to keep our families strong; and

WHEREAS, North Carolina will undoubtedly face challenges to our current strong marriage laws; and

WHEREAS, a number of bills have been filed in our Legislature but have not been brought to a vote.

BE IT RESOLVED, that NCFRW hereby strongly urges all members of the North Carolina Legislature to take immediate action in supporting and promoting House Bill 493 and Senate Bill 13 to amend the North Carolina Constitution to specifically define marriage as the union of one man and one woman and placing the amendment before the voters of the state.

DRIVERS LICENSES FOR ILLEGAL IMMIGRANTS

By the North Carolina Federation of Republican Women

WHEREAS, North Carolina has welcomed people of all races, religions, ethnicity and socio-economic classes who enter this state legally and derives its greatness from the contributions of many races and ethnic groups that compose its citizenry; and

WHEREAS, the state of North Carolina has become a haven for those in this country illegally who seek to obtain drivers licenses; and

WHEREAS, North Carolina is one of only eleven states that does not require legal immigration status to obtain a license; and

WHEREAS, the state of North Carolina has a responsibility to protect its citizens and legal residents from unlawful persons, including those here illegally who operate vehicles without insurance causing additional costs to our citizens.

BE IT RESOLVED, that the NCFRW strongly urges all legislators to support and promote any and all legislation to prohibit the issuance of drivers licenses to those who are in this state illegally.

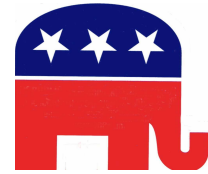


THE TARDY TABLE

President's Message

Proud to be an American

Two decades ago as a military spouse in West Germany, I experienced the lingering damage caused when good people remain silent — thugs and criminals gain control, become dictators and ignite global wars that have to be fought to free the oppressed and to maintain national and homeland security.

This past week when Michelle Obama expressed her lack of pride in this country, I was reminded of our family experiences in West Germany. Her remarks evoked old memories of standing one day on both sides of the Brandenburg Gate in Berlin. The West Germans greeted us with cheerful smiles and safely walked their streets; the East Germans frowned and looked fearful amidst the armed military walking the streets. How did they know we were Americans? My husband was required to wear his uniform in East Berlin.

I've often thought that all U.S. citizens should once in their youth drive coast to coast to see our rich diversity — the core of our strength — and to take a trip back in time when Check Point Charlie divided East from West Germany — at all times with a history book in their hands to remind them how fortunate we are and how precious our birthright is. Today, I especially wish Michelle Obama could do these things. Perhaps then, she might have some appreciation for what it means to be a United States citizen and First Lady of this great country.

In my opinion, Mrs. Obama intentionally played a card her husband's campaign has supposedly carefully avoided — the same one that caused John Edwards to withdraw from the presidential campaign after four expensive years of campaigning coast-to-coast. Edwards failed to convince the electorate that we're two Americas. Both of the Obamas and Hilary Clinton will likewise fail to drive that wedge home to victory in November. As diverse as we are, we are still "... one nation under God, indivisible with liberty and justice for all" and we take pride in who we are.
